1. Comprehensiveness

As stated in the W-BAD Report, a large amount of detail and facts had been made necessary to neutralise the manipulations, distorting of reality, flipping of the script and psychological abuse that has been undermining the W-BAD platform in recent years.

Any lesser attempt would have only resulted in a long drawn out complicated affair with much broader unintended damage to the wider community.

2. Timing

The timing was governed by the sheer enormity of the task. While working on it every weekend and every available minute of every day for almost an entire year since the initial proposal on 30 August 2019, I continued preparing relentlessly right up until the very last minute, having postponed possible publication dates countless times over many months. Sunday, 4th July was simply the latest I could leave it.

As well as having resulted in the liberation of W-BAD on independence day, the unintended delay also offered protection from any potential claims that nothing happened this year because of the denunciation, when in actual fact, none of those responsible had planned anything for 11th July anyway, as they continued to dismantle, neglect and misrepresent the platform.

3. Nature of Denunciation

The denunciation was an absolute last resort which was preceded by years of efforts to stem the damages to W-BAD, including diplomacy, appeasing ongoing attacks (maliciously contrived claims and accusations), trying to find middle ground, making allowances etc., while trying to maintain unity to the point of my own detriment, as well as it was preceded by the more recent proposal submitted before the eighteen witnesses on 30 August 2021.

Even then, while making the public call, I was not denouncing individuals per se, who have individually contributed to the wider cause in their own ways, rather I was denouncing the W-BAD Board collectively (which happened to be comprised of those individuals) for causing large-scale damages to W-BAD and for misrepresentation of the platform as an all-out last resort.

While pondering the question as to whether this was avoidable, perhaps it would also be reasonable to consider whether the initial proposal sent on 30 August 2020 was sufficiently used as an opportunity to provide an alternative way around things.

Given the psychological manipulations associated with DARVO and the fact that any lesser attempts would have only resulted in further complications, without bringing about any much-needed change for W-BAD, in hindsight, it is difficult to imagine any other way that would have produced a better outcome.

4. Potential Limitations

For me personally, I have given everything to not only creating W-BAD but also in my efforts to maintain it over the years, latterly working against opposing internal forces, and again in my efforts to resurrect the platform while living on the breadline in a foreign country.

Those responsible for the damages, however, can be thankful that there was insufficient time to complete subsequent years in The W-BAD Chronicle, which show the maliciousness and nastiness that would have had people reeling in disbelief.

The communication exchanges show that, while in a state of chronic depression and compromised personal circumstances (section thirteen of the chronicle), I was taking a stand for the real W-BAD, remaining diplomatic and staying true to the W-BAD principles. It was a true case of courage under fire – something that for now remains behind closed doors.

5. My Approach

As above, I had exhausted all possible means over several years to stem the damages to W-BAD. Despite the mislaid rumours, my general approach to working with people can be tracked anywhere throughout The W-BAD Chronicle using the following search keys.

6. Effects on Reputations

I would agree that when people intentionally cause largescale damage, betray trust, unfairly and wrongfully undermine other people's integrities and credibility, pursue relentless and merciless attacks, and destroy relationships, yes, it usually tends to affect their reputations.

Under such circumstances, the questioning of their reputation can only be considered as a normal response. However, for them to turn around and push the question of responsibilities and reputations onto other innocent parties is both unrealistic and unfair – rather it is something they will need to look at more closely themselves, as they look to move forward.

7. Mediation Process

(As stated in the attached document: *Closing the W-BAD Issue and Moving Forward*)

After launching the public call on Sunday, 4th July it took a few days for me to respond to Geraldine, who had offered to mediate. This hesitation was due in part to years of prolonged psychological abuse.

I was initially only debriefed on the responses, as I was unable to bring myself to look at them because of said abuse and having become exhausted from preparing relentlessly for almost an entire year, right up until the very last minute.

Once in contact with Geraldine, while negotiations were set to proceed, those who had been entrusted with W-BAD continued to remove large amounts of content from the website (in addition to that already removed previously). The YouTube channel with its large number of subscribers was decommissioned and around 2,300 likes and 2,000 followers were erased from the W-BAD Facebook Page.

This together with the subsequent stigmatising of the platform left it with no value and no reason to negotiate.

I was reluctant to lock the public call to revive W-BAD pages on my website while further destruction to the W-BAD platform was unfolding, which also contributed to the delay, before eventually having them locked on Saturday 10th July (within a week of launch).

On Tuesday, 13 July, as an act of good faith, I physically removed both pages, and now they do not exist at all.

In contrast, on Thursday, 15 July, just two days later, while asking for protection and expressing concerns about their reputations, after having already caused systematic largescale damages over many years, followed by the more recent malicious destruction, those involved proceeded to decommission both the W-BAD Facebook page and the website.

They did so in the knowledge that there could likely be no way of reviving the people's platform that carries Prof. Heather Ashton's honour ever again. It must be noted that this wasn't anything new, as it has been an ongoing steady escalation of systematic and intentional dismantling over many years.

The backing away from negotiations, however, may have been a blessing in disguise. The US Home Security has a policy of advising not to engage with certain groups that pose threats (same principle applies to organisations and social groups), namely: 'Never Negotiate'.

The reason being that this would only serve to further protect the aggressors while undermining the truth and integrity.

The only thing of value remaining is the internet domain registration; however, I am unwilling to jeopardise myself, W-BAD or anyone who may become associated with W-BAD either now or in the future by entering negotiations in the absence of good faith where there has been nothing but repetitive displays of malicious intent over many years.

While my public call to revive W-BAD was for the sole purpose of requesting that basic requirements be met to allow the platform to function for the people, those in control instead chose to inflict further damages, negating any potential basis for negotiations before decommissioning the entire platform, turning their backs and walking away, while now effectively holding the ability to revive W-BAD to ransom.

8. Claim of Lack in Skills

The comments they provided about not being tech savvy enough to have avoided further largescale damages to the website and social media platforms are nothing more than convenient excuses, as the intentional and systematic damages have been a steady progression over several years now, not to mention that they are indeed highly skilled and tech savvy to the contrary.

9. Claim of Disassociation

Similarly, the comments during the days that followed, suggesting that people no longer want to be associated with W-BAD seem a little too convenient. It is difficult to believe that they contacted all those individuals in the space of just one or two days and discussed with them the situation and whether they wished for their videos to remain on the W-BAD YouTube Channel. It would seem more likely that they obliterated the entire channel in a single intentional strike.

For the record, if there is any reason as to why people may not want to be associated with the W-BAD platform any longer, it is because of the destruction, lost momentum and associated riffs that those responsible have caused, which is another reason why the platform now has stigma attached to it, leaving it with no value and no reason to negotiate.

10. Accountability / Responsibility

Despite the intentional destruction that has been continuing for several years in plain sight for all to see, they are now portraying themselves as the hapless victims and me as the aggressor in all this – an exemplar, classic / prime example of [DARVO](#) at work with the exceptionally skilful and highly manipulative effects of Tribal Gaslighting and Betrayal Blindness (eyes wide shut, as explained in DARVO) likely working in the background within context of the wider community.

I would recommend browsing this article. It is a short 5 minute read that gives a clear easy-to-understand overview in relation to what is happening and how this works ([read passage](#)).

The bottom line is that despite appearances and the good work done as individuals, with ready-to-rise hostility levels, the professional advice is to never engage or negotiate.

11. Disservice to the Community

Despite some concerns, it is not the truth that forms a disservice to the community, nor is it The W-BAD Chronicle that houses it.

The disservice to the community is the ruthless, malicious and systematic largescale destruction that has ensued over several years while removing the entire team, dehumanising the platform and undoing everybody's valuable work – this is what forms the disservice to the community.

I'm just so glad that I have now broken free from it all – a feeling of relief that can only be paralleled with breaking free from benzodiazepines 20 years ago.

I agree with comments that the core argument is between four individuals but the damage they have calculatingly inflicted over several years has an effect on everyone, and I agree this is unfortunate, but this is what people who engage in [DARVO](#) do: snakes will bite by nature, and these people will destroy by nature, either overtly or covertly (from within), but the results are all the same.

12. Community Involvement

As for not involving the community, I agree that this would have been ideal. I built this platform for the community, and those in control have since totally decommissioned it while maintaining their innocence.

I made every effort possible, over several years, to prevent the ongoing damage, with the public call being the very last resort, so by forcing matters to progress to the ultimate conclusion, those responsible have in effect involved the community through their own actions, not mine, and let it not be forgotten that W-BAD belongs to the community.

13. Heather's Name

The recent public call to liberate W-BAD from the misrepresentation and systematic prolonged damages does NOT represent Heather, nor was it ever intended to.

It represents 'the truth' and the 'protection of W-BAD' – a platform that carries Heather's name, and both John Ashton and I strongly believe that she is proud.

As well as establishing W-BAD for the community, I established the platform in Heather's honour. Just as the largescale destruction and dehumanising of the platform has been shutting the people out, it has also been dishonouring Heather, and it needed to be brought to an end.

14. Request for Concealing the Truth

I feel worried that amidst the manipulations and potential social grooming, people may have somehow lost track of the truth, and yet it is right before our eyes (a case of eyes wide shut).

Chapter 15 of The W-BAD Chronicle clearly shows in detail the extent of the malicious damages done, the reversal of guiding principles and undermining of integrity by the few people in control, who now want to bury the truth at the cost of those who have had to suffer for it.

For the sake of peacekeeping, however, I am willing to conceal the truth at their request, which goes against all morals and beliefs of righteous people, but I will never destroy it, as it is the truth that provides protection for everyone accordingly on all sides without bias or discrimination.

15. Assumptions of Anger, Worry / Soliciting Attorneys

Despite concerns raised, it may come of a surprise, but I am neither angry or worried, nor do I intend to solicit any attorneys, as there is a higher more divine power protecting us all, namely the truth. Those responsible are the ones with the problems, not myself or any other innocent parties.

The truth is more powerful than any mere mortals including any attorneys that walk the face of this earth for a definite period. The truth is eternal and fears no mortal – indeed it is what W-BAD was built on (before succumbing to questionable forces).

16. Reported Personal Concerns

Considering the intentional damage done and the malicious nature in which it was carried out, it can only be considered natural for them to be a bit worried now that there is a full record of the truth available.

I guess the degree to which the truth hurts is proportionate to the degree of malicious damage inflicted onto the W-BAD platform and other people, particularly myself.

If the truth is hurting to such a degree, perhaps they will need to take a closer look at the way in which they conduct themselves, as they look to move forward.

In light of the mass destruction, and while falling short of deserving any degree of pity, those responsible can be reassured that the best way for them to avoid another encounter with the power of the truth that bears such pain is to avoid any further challenges to the truth itself, avoid any contest of W-BAD properties and cease any rumours and personal attacks on W-BAD, me and anyone else who is associated with the platform or may become associated with the platform at any time in the future.

This is the best guarantee they can get, and they should be thankful for it, counting themselves lucky, considering the malicious and intentional damage they have done to W-BAD over several years.

The manipulations are crafted at a skill level well beyond anyone's imaginations. As mentioned in the W-BAD Report, the professional advice is to walk away, but I wasn't going to turn my back on W-BAD, especially after receiving pleas from others a year ago, which spurred everything into motion, and now we are in a more favourable position, looking to go forward better than ever before.
